1. Review of Activities (2022–2024)

The presiding officer requested permission from the delegates to open the meeting. The delegates confirmed that representatives from nearly all regions were present and that the quorum was met.

The Chairman declared the II Congress of the Asian Belbogli Kurash Confederation open and expressed gratitude to all participants.

He extended thanks for the active participation in the Asian Championship in belt wrestling among boys and girls aged 15–17 (born in 2008–2010), organized in accordance with the Cabinet of Ministers of the Republic of Uzbekistan's minutes dated May 17, 2025, No. 34 (06-27/1-198).

President Muminhuja Muratov presented the Confederation's report on its activities for 2022–2024. He also shared the audit report with the participants.

The presiding officer submitted the report for an open vote.

Voting results:

- Abstained: 0

The report was unanimously adopted.

2. Organizational Matters

Regarding the second agenda item, the presiding officer informed the participants that the Confederation's Secretary General, Farhod Atadjanov Uktamovich, had taken a new position elsewhere and proposed his dismissal from the Confederation.

He nominated Sardor Ravshan ugli Dastirov as his replacement.

The delegates unanimously approved the candidacy of S. Dastirov by open vote.

Farhod Atadjanov was removed from the Executive Committee and relieved of his duties as Secretary General of the Confederation.

Sardor Dastirov was elected as a member of the Executive Committee and Secretary General of the Confederation.

3. Admission of New Members

Ravshan Dastirov, Chairman of the Uzbekistan Belbogli Kurash Federation, addressed the third item on the agenda.

He stated that several applications for membership in the Confederation had been submitted during 2024.

Following a review of the submitted documents, it was proposed to admit these national federations to the Confederation and issue membership certificates accordingly.

Voting results:

- Abstained: 0

The proposal was unanimously adopted.

Membership certificates are to be formalized and sent to the respective national federations.

4. The Chairman announced the official closure of the II Congress of the Asian Belbog'li Kurash Confederation.

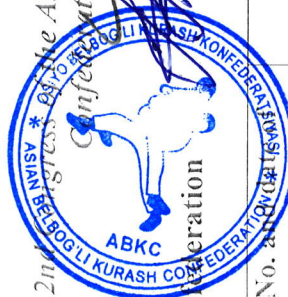
